

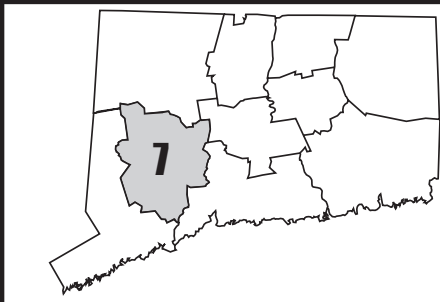



News from the Deputy Team

Inspections • Code Reading • Ritual • Ritual Challenge • Support • Instruction

One of the purposes of providing this column each month is to provide useful instruction regarding ritual and procedures. It has become apparent from visiting Granges around the State there are many Masters who are not aware of the protocol for recognizing guests at our Grange meetings.

When I first became Master of Winchester Grange, outgoing Master Shirley Lemieux handed me a small sheet of paper entitled, "Recognition of Honored Guests as Prescribed by the Connecticut State Grange." I have never seen this in print in any other place than this note, but it is a good guideline for properly recognizing visitors to our Granges.

Recognition of Honored Guests as Prescribed by the CT State Grange

Guests are recognized in the following order:

- 1) State Master and Spouse
- 2) National Officers & Past Voting Delegates
- 3) Elected State Officers (announced in order beginning with the Overseer, if the Master has already been recognized)
- 4) Appointed State Officers (beginning with Deputies, then Committees - announced in order of rank)
- 5) Pomona Masters
- 6) Subordinate Masters

Even though there may be members of the "home" Grange that might hold higher offices, they are not recognized at their own Grange meetings.

If a large gathering is anticipated, have someone make a list for you before the meeting, in the order listed here. It will make everything go a lot smoother and save some time.

There is one exception to this procedure... Deputies. If a Deputy State Master is making an official visit to your Grange, they are always recognized first and should be escorted first, even before the State Master. Official visits usually are inspection nights or schools of instruction. This is the rare situation when the Deputy ranks higher than anyone else at the meeting.

This also brings us to another important point. Deputy State Masters carry the weight and authority of the State Master. Whenever a Deputy is present at your Grange, treat them as you would the State Master.

I believe the members who do not practice these procedures simply are not aware of them. I hope every Master will put this information on a note card to be kept with the rest of their meeting paraphernalia to be available whenever the need arises.

The State Master has already acknowledged the resignations of Victor Salazar of Mountain County Pomona and J. Allen Cameron of Quinebaug Pomona. I join Brother Jody in thanking both of them for their hard work during this past year. Both agonized over their decisions. In then end, we all knew they made the right decision. There is nothing more important for them than getting the best educations possible. They leave tremendous voids for us to fill but we look forward to the time when they will be able to return to their Grange work. While Victor is moving to South Carolina to attend Clemson, J. Allen will continue to attend UConn. I am pleased to tell you that J. Allen has agreed to be a permanent Special Deputy for upcoming State Sessions and will remain Deputy of Quinebaug Pomona until the close of Session.







Wagons of the Past; Autos of Today

Here are a few facts found in this article from the Connecticut Granger in October 1981 written by Sperry New Holland:

Who would ever think that today's modern automobile could be linked to a unique farm wagon that was the ship of inland commerce up to the mid-1800's.

But there's evidence pointing in that direction, according to Sperry New Holland, whose worldwide farm equipment manufacturing headquarters is located in Lancaster County, PA, birthplace of the famed Conestoga wagon.

Even the way we drive may have its origins with the Conestoga. These boat-shaped, homespun covered wagons were driven from the left by a walking wagoner.

The lead horse was on the left and passing also was done on the left.


Our autos are equipped with brakeshoes. Conestoga drivers often nailed an old shoe sole to their wagon's braking mechanism to slow their heavily laden vehicles on hilly terrain.

The running boards of vintage autos have long since disappeared from modern design. Many Conestogas had a board that slipped from beneath the wagon bed to provide respite for a weary driver. Then it was called a lazy board.

The roads the wagons traveled were either dusty or muddy. Metal covers, hub caps, were fastened to wheels to protect axles. When a wagoner had to grease an axle, he used a wagon jack, the forerunner of the tool found in every trunk today.

"Come home with your bells on" is still a parting comment for someone taking a trip. In the days of the Conestoga, it meant the returning horse hitch would still have its melodic harness bells, which did not need to be surrendered for help along the way.


Louise was calm, soft spoken, warm and friendly to everyone. We don't know if

Dust begins to settle in Hartford

The main focus of the 2011 General Assembly was on the State’s finances, just as it has been for the last three years. A family can postpone paying for things they want or need by charging them on a credit card, but eventually the day comes when they have to start living within their means. The State is no different and the day is here when the State must start living within its means. Everyone is going to have to bear part of the means. The state income tax rates were raised on all income earned in 2011, but the withholding for this began August 1. The amount withheld from everyone’s income will have to be more to cover the increased taxes they will have to pay next spring. The maximum deduction for local real estate and personal property taxes has been reduced from \$500 to \$300 which means that everyone who was taking the maximum reduction will have to pay at least \$200 more in state income tax. The general sales tax was increased from 6% to 6.35% and many things that used to be tax exempt are now taxable. Among the items now taxed are clothing and shoes costing less than \$50, over the counter medicines and fabric and other supplies for making clothes at home.

The Department of Agriculture came through the financial problems in good shape compared to many other state departments and agencies. The General Assembly authorized \$10 million in new bond funds for farmland preservation. This, plus the money from the Community Investment Act, will allow the Department of Agriculture to maintain its farmland preservation program at its current pace for the next two years. Funds are also available to subsidize dairy farmers when their cost of production is more than they receive for their milk.

Until this year any farmer who wanted to sell his products at farmers markets in more than one health district had to pay for an inspection and obtain a permit in each health district where he wanted to participate in a farmers market. Public Act 11-191 provides that an inspection and permit from any health district is good throughout the state.

The so-called “ten mil” program which postponed most of the local property taxes on farm land before the “490” program existed is scheduled to phase out in 2012. Public Act 11-198 will allow the owners of land under the ten mil program to transfer it into the 490 program without having to pay the postponed taxes on their land and the timber on their land. Without this act many land owners would have been forced to sell some or all of their land to pay the taxes when the ten mil program expires next year.

Governor Malloy has just announced that the animal rescue program operated by the Department of Agriculture will have to be abandoned because of the

budget crunch. Under this program farm animals that were neglected or uncared for could be seized by the Department of Agriculture. The animals were moved to one of the prisons where the inmates nursed and cared for the animals until they were healthy. The animals were then sold at auction to recover the cost of their care. While it may seem cruel that the State could seize a farmer’s livestock, there were several cases in recent years where the animals were starving because the farmer could no longer afford to buy any feed.


The Grange supported a bill that would have transferred regulation of outdoor wood burning furnaces from local control to the State. The Environment Committee supported this bill, but the Senate did not act on it before it adjourned. The net result is that towns can still pass any ordinance they want concerning the use of outdoor wood burning furnaces. In several towns all such furnaces have been banned because some people did not know how to use them properly to avoid polluting the air.

Some vegetable farmers now sell shares of their crop to people who want to have fresh local produce all summer. Those who purchase the shares go to the farm each week and pick up their share of whatever crop is ready for harvest. A bill was introduced that would have allowed dairy farmers to sell shares of their milk production and the shareholders would go to the farm each week to pick up their milk. This was primarily of interest to those who prefer raw milk to pasteurized milk. This bill was not approved by the Environment Committee and so it never reached the floor for debate.

The former Public Utilities Control Commission was merged with the former Department of Environmental Protection into a new Department of Energy and Environmental Protection primarily so utility companies will not have to go through two sets of applications and hearings for the same projects. A bill to move the park, forest, fisheries and wildlife sections of the former DEP into the Department of Agriculture was not approved by the Environment Committee.

Several people from various organizations including the Grange asked me about two bills that at first glance seemed to create many regulations concerning bingo, raffles and similar games of chance. All that these bills did was merge the Commission on Special Revenue into the Department of Consumer Protection, but each bill was over 250 pages long because of the many references in the general statutes to the Commission on Special Revenue that all had to be changed to the Department of Consumer Protection. The only change for anyone applying for a license or permit is the name on the forms.

P.R. Contests - Something for Everyone

The Public Relations committee is offering a total of six fun contests this year. Let's take a quick peek at each one.

- 1) "Spot On" - 30-Second Grange Video Commercial Contest: Think of an idea for a commercial representing your Grange. Make us laugh. Make us cry. Make us say, "Wow! I want to join the Grange." Make it something you'd want to see on TV. You write it. You cast it. You direct and shoot it. You have total creative control. The Commercial must be thirty (30) seconds in length, including any tags. The entry must reflect the theme "Community Grown."
- 2) "Spreading the Word" - Connecticut State Grange Website Participation Contest: Spread the Word about your Grange, its projects, activities and events by submitting content to the Connecticut State Grange website. Submissions can be articles, photos, and scrapbook items (such as newspaper clippings and historical data). Submission period runs January 1, 2011 - October 1, 2011.
- 3) "Show Us Your Stuff" - Grange Marketing Contest: One of the best ways for the Grange to reach the community is to spread the Grange name. Show us a collection of the ways that your Grange promotes itself in the community through its marketing efforts. The possibilities are endless. Some examples include:
 - Hosting and then publicizing an Agricultural Fair
 - Participation in community programs and projects, such as the Farmer's Markets, Chamber of Commerce, Recycling Centers, Can and Bottle Drives, etc.
 - Community Displays and Booths at local non-Grange sponsored community events
 - Newspaper, Television and Radio Advertising
 - Signage in your community
 - Original printed pieces, such as Flyers, Brochures, Letterhead, Postcards and Notecards
 - Participation in internet activities such as having an individual Grange Website and Social Media such as Facebook and Twitter
 - and more!

To enter, submit a report of NO MORE than 10 pages containing a description and photos/scans on how your Grange promotes

itself through marketing. Note that this contest is not a community service contest, although it incorporates community service fundamentals. Entries should concentrate on the promotional aspects of the projects your Grange participates in.

- 4) "Convey the Message" - Best Grange-written Press Release Contest: An engaging press release with an interesting 'hook' or angle is an excellent way to gain exposure for your Grange and can lead to publication in newspapers, magazines and on the internet. Show us how your Grange uses Press Releases to capture an audience. Entries must be an ACTUAL press release written and used by your Grange, should be less than 400 words in length, and follow the proper style and format as described in the Connecticut State Grange Public Relations Tool-Kit booklet.
- 5) "Let's Advertise" - Best Grange Event Poster: Set your imagination lose! Let your mind run wild, but be sure that your artwork relates to your Grange event. Submissions must be an ACTUAL poster designed, executed, and used by your Grange for an event. Posters should be either 8.5 x 11 inch or 11 x 17 inch in size, and may be in either black and white, or color, and can be computer designed or hand-drawn.
- 6) "In the News" - Best Newspaper Article Contest: Research has revealed that the news media is responsible for influencing the thoughts and behavior of the general public. Here's an opportunity to show how the Media has helped promote your Grange through the written word. Entries must be an ACTUAL printed or published newspaper article written about your Grange.

All of the details, rules, and information for the contests can be found on the Connecticut State Grange website at www.CTStateGrange.org, and are also available in the BlueBook. The deadline for all of the Public Relations contests is October 1st. We hope that the variety of contests will appeal to Granges of all sizes - as the saying goes, there's something for everyone.


The Elevator Speech
